# INTERNAL RULES OF CAMPING LE CURTELET

#### 1 CONDITIONS OF ADMISSION:

# NB: The fact of wanting to stay at Le Curtelet Camping implies the prior acceptance of its rules of procedure and the commitment to comply with them.

To be allowed to enter and settle on the campground, you must first have received the authorisation of a person in charge of the campsite.

Minors under 18 years of age who are not accompanied by their parents will be admitted only upon presentation of the written parental authorisation and accompanied by a responsible adult.

The campsite structure does not accommodate large groups.

Any violation of the rules of procedure may be punished by the expulsion of the author.

The manager may use law enforcement if he deems it necessary.

#### 2- ADMISSION FORMALITIES.

Anyone wishing to enter the premises of the Camping, for any reason, must first present themselves to the head of the reception office.

Depending on the circumstances, identification will be required.

#### 3- INSTALLATION:

The tent, caravan or motorhome and all camping equipment shall be installed at the location specified by the office manager or person in charge. Double axle caravans are not accepted on the campsite.

## 4- HOST OFFICE:

Opening times, every day:

- from 9:00 to 12:00 and from 14:00 to 18:00 in April, May, June and September.
- from 9:00 to 12:00 and from 14:00 to 19:00 in July and August.

All information on the services of the campsite, information on refuelling possibilities, sports facilities, tourist attractions in the area and various addresses that may prove useful are kept at the reception desk available to clients.

#### 5- PAYMENT AND RENTAL TIMES:

The total payment for stays on the campground must be paid upon arrival at the reception desk.

Location: The day of rental of the site is counted from 14h00 to 11h00. The site must be released at 11h00. Any day started is due.

Mobile home: The rental day is counted from 15h00 to 10h00. The mobile home must be released before 10h00, after a contradictory inventory. Any day started is due.

#### 6- NOISE AND SILENCE:

Camping users should avoid any noise and discussions that might disturb their neighbours.

There must be total silence between 10:00pm and 7:00am.

Each tenant is responsible for the disturbances and nuisances caused by the people staying with him.

If a resident of the campsite causes such disturbance or nuisance to other residents, he or she may be expelled and his or her stay will be immediately interrupted.

#### 7- ANIMALS:

Dogs are accepted on the campsite at a maximum of two per location and must be kept on a leash at any time.

Their welcome meets two conditions:

- valid anti-rabies vaccination;
- identification by tattoo or chip certified by the Central Canine Society.

Dangerous dogs as well as those of 1st and 2nd category and new pets (NAC) are not accepted on the campsite.

No animals are allowed in mobile homes.

Dogs and other animals should never be left free and always kept on a leash. They must never be left alone and always under the supervision of their master.

Dogs are not allowed on the beach or in the water.

Dogs can swim in the morning before 10 a.m. and in the afternoon after 6 p.m.

Access to premises such as toilets, laundry ... at any time is strictly forbidden. (Exception for blind guide dogs).

As a reminder and as an example, dogs cannot be showered in the sanitary facilities of the Camping.

#### 8- VISITORS:

Visitors must present themselves at the reception desk before entering the premises.

An entrance fee is payable by each visitor. This entry fee shall be charged to the Campeur visited unless otherwise agreed.

Their vehicle should remain in the outdoor car park of the campsite.

Number of visitors limited to 5 per location and per mobile home.

#### 9- MOVEMENT AND PARKING OF VEHICLES:

The campsite Le Curtelet is "camping without motorised vehicles" in July and August. During this period, motorised vehicles are allowed to enter the campsite only for installation and departure.

During the months of July and August, motorised vehicles will have to be parked in the car park next to the campsite.

Inside the campsite, vehicles must drive at a speed limited to 5km/h.

Only vehicles owned by campers staying at the campsite may be used.

Traffic on the campsite (when permitted) is prohibited between 10 pm and 7 am, and vehicle access is closed at 10 pm.

#### 10- HOLDING AND FACILITIES:

Everyone is obliged to refrain from any action that could harm the cleanliness, hygiene and appearance of the campsite.

It is prohibited to pour polluted water on the ground or in the gutters. Caravan or motorhome owners must drain their waste water in the facilities provided.

Garbage, garbage of any kind must be deposited in the garbage can.

Sorting of waste is mandatory. Sorting containers are located outside the Camping 50 metres from the entrance.

Sanitary facilities must be maintained in a constant state of cleanliness by users.

Washing of laundry or crockery is strictly forbidden outside the boxes provided for this purpose.

Washing is permitted, provided it is discreet and does not disturb neighbours.

Plantations and floral decorations must be respected.

It is forbidden to plant nails in trees, cut branches, make plantations. Nor is it permitted to demarcate the site by personal means or to dig the ground.

Damage resulting from any degradation caused to vegetation, fences, soil or campsite facilities shall be repaired at the expense of the author. The location used during the stay should be restored to its original condition.

#### 11- SAFETY:

A/Fire:

Coal barbecues are allowed at a height of 50cm from the ground.

Wood fires are prohibited.

The stoves must be kept in good working order and must not be used in a tent.

In case of fire, immediately inform the management.

A first-aid kit is located at the reception desk.

### B/Flight:

The presence in the campsite of any suspect must be reported to the person in charge of the campsite.

Campers are encouraged to take the usual precautions to safeguard their personal belongings and equipment.

#### **12-GAMES:**

Access to the various playgrounds is entirely the responsibility of the users.

Parents are obliged to accompany their children there and under their sole responsibility. No violent or disturbing games can be organised either on the playgrounds or in the Campsite.

It is strictly forbidden to climb trees.
